

UTILITY VEHICLE/GOLF CART POLICIES

Wehinahpay Mountain Camp, Conquistador Council, BSA

The following policies apply to the use of golf carts and any utility vehicles owned or rented by the participant for use at the designated Conquistador Council property

Driver Requirements and Procedures:

1. UTVs may only be used by certified/ approved adults 21 years of age or older.
2. All individual drivers using a UTV must complete the online ROHVA training, regardless of sharing ownership of one UTV: <https://cbt.rohva.org/login/index.php>
3. In-person training is also required, this can be done upon arrival but may take some time away from your event. This In-person Training is good for 1 calendar year AND ONLY FOR WEHINAHPAY MOUNTAIN CAMP. WMC-UTV permits cannot be transferred to other BSA camp or camp properties as a “proof of in-person training” Issuance of the permit is for a specific adult(s) using a specific vehicle and does not grant permission for other drivers or vehicles.
4. Adults must provide the vehicle themselves and must be able to drive it, refuel it, and remove it from camp in a safe and legal fashion. Repair and fuel services cannot be expected to be available or provided by Conquistador Council.
5. Both the vehicle and the operator(s) must register with the Camp Office BEFORE arrival with the following information.
 - Front and back of Valid Drivers’ License
 - Proof of vehicle insurance
 - Release of Liability form (Back of this page)
 - Online Training Certificate (linked above)

On-site Policies:

- a Drivers should obey all posted speed limit and traffic signs.
- b Vehicles should stay on approved camp roads
- c Passengers must be approved by camp administration
- d Vehicles may only be operated after dark if equipped with working headlights.
- e Vehicle operation should not interrupt or spoil the experience of any Scout or participant, or program presentation such as campfires, flag ceremonies, etc.

Wehinahpay Mountain Camp does not accept this form as certification to drive any camp vehicles, UTVs or ATVs.

Release of Liability

I understand that The Conquistador Council (under the authority of the camp ranger or designated party) reserves the right to revoke driving privileges at any time and for any reason. The Administrative staff of each event will maintain the driver eligibility list.

I understand that any damages to the vehicle (golf cart, truck or trailer) is the responsibility of the assigned operator. This waiver and the above required trainings are not transferrable to any other persons nor any other vehicle than signed for below. I will not transport any persons or attempt to transport any persons under the age of 18 or not signed for below.

I have read and agree to the UTV/Golf Cart vehicle policies above. I understand that failure to follow these rules or others issued by the Camp Director or Camp Ranger will result in the revocation of the operating permit and possible removal from camp property.

RELEASE AND INDEMNITY/HOLD-HARMLESS AGREEMENT

THIS INDEMNIFICATION EXPRESSLY INCLUDES ANY CLAIMS ARISING OUT OF THE BOY SCOUTS OF AMERICA CONQUISTADOR COUNCIL BSA'S OWN NEGLIGENCE OR FAULT OR THAT OF THEIR EMPLOYEES, AGENTS, REPRESENTATIVES, OR VOLUNTEERS. I AGREE THAT THE INDEMNIFICATION INCLUDES THE AMOUNT OF THE CLAIMS, THE EXPENSES OF DEFENDING AGAINST THE CLAIMS, COURT COSTS, AND ATTORNEYS' FEES.
